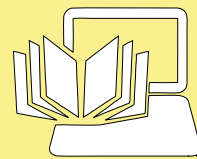

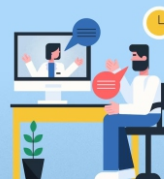

This is in continuation to the Council’s above cited Circulars.


In this connection, it is informed that –

It is further stated that 388<sup>th</sup> Executive Committee of the PCI in its meeting held on 28.01.2023 has decided that the Exit Examination under “Diploma in Pharmacy Exit Examination Regulations, 2022” will be implemented from 2022-2023 batch of D.Pharm Course.

After having passed the Diploma in Pharmacy Exit Examination, a candidate shall be entitled to registration as a pharmacist subject to fulfillment of the conditions enumerated in section 32(2) of the Pharmacy Act, 1948.
